LACES is the student management system software created and managed by LiteracyPro Systems, a division of GeniusSIS, a nation-wide adult education vendor. Training will include topics on using the search and reporting functions of LACES for data output and analysis. There will also be reinforcement practice and time to generate implementation considerations. A session led by the VDOE team will review the many changes that have been released by the National Reporting System this year as released to Virginia providers in Adult Education Director's Memos.
